Revised boundary consultation

The Mayor of London held a public consultation on the proposed establishment of a new proposed Mayoral Development Corporation for Old Oak and Park Royal, which ran from June 18 to September 24, 2014. The proposed Mayoral Development Corporation would support regeneration across the area including delivery of new transport infrastructure, 24,000 new homes, 55,000 new jobs and the protection of Wormwood Scrubs.

During this public consultation over 300 comments were received. In response it is proposed that two boundary revisions be made to the original area of the proposed Mayoral Development Corporation (shown overleaf).

This additional consultation will run from Wednesday November 5 until 5pm on Wednesday 26 November 25 2014 and we would welcome your comments on the following two proposals.

### Area 1

The first proposal is to change the proposed boundary of the proposed Mayoral Development Corporation Area to exclude land to the west of the A406, located in the London Boroughs of Brent and Ealing. This land includes the industrial areas of Northfields, Water Road, Abbeydale Road, Queensbury Road, North Circular Road, Brent Crescent and Park Avenue (see Area 1 on the map overleaf). This area is considered to be part of the Councils' emerging regeneration plans for Alperton and the Councils are keen to bring forward plans for the area.

#### Area 2

The first proposal is to change the proposed boundary of the proposed Mayoral Development Corporation Area to exclude land to the south of Wormwood Scrubs, located in the London Borough of Hammersmith and Fulham. This land includes Wormwood Scrubs Prison, Hammersmith Hospital and the Linford Christie Stadium. The area is considered to be more closely aligned to Hammersmith and Fulham Council's emerging plans for the White City area.

Should a Mayoral Development Corporation be established the Mayor would continue to work with Brent, Ealing and Hammersmith and Fulham Councils to realise the Vision for Old Oak and Park Royal and the surrounding areas.
